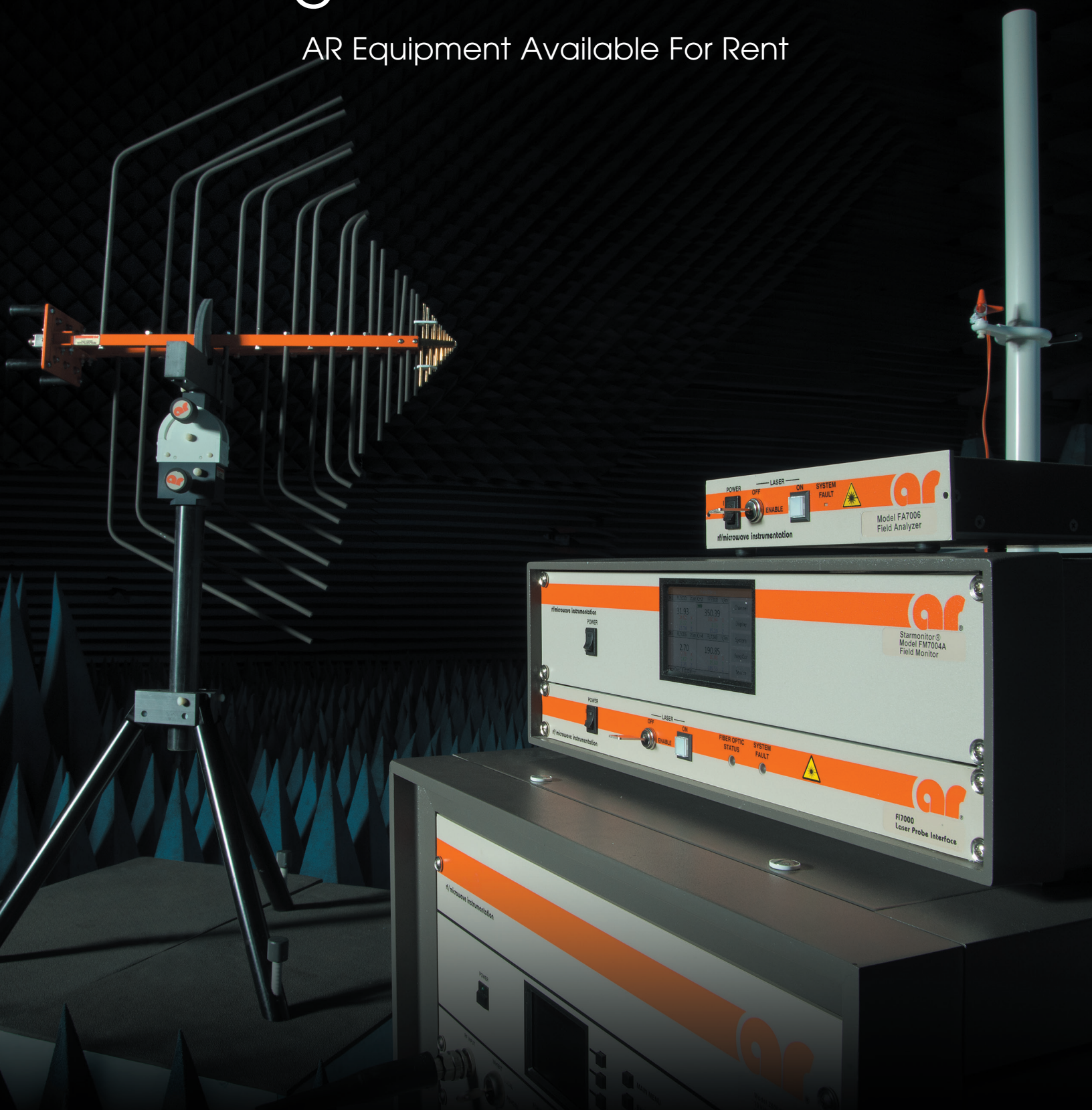

The 3-Month, 10%, 95% Buyout Credit Plan

If you're serious about eventually buying the equipment, this is a great way to acquire it now while "saving" toward the purchase. The minimum rental is three months and the rate remains constant at 10% of list price for the length of the rental. If you choose to buy, 90% of the rental fee paid is credited toward the purchase (up to 95% of list price). You may rent the equipment as long as you need or execute a buyout at any time. Return the equipment after the three-month rental minimum with no penalties.

The 3-Month, 10%, 50% Credit Plan

Minimum 3-month rental. First month's rental is 10% of purchase price. The rental declines each month until it reaches 2% of list price in month 32 and remains there for the length of the rental. If you choose to buy, 50% of the rental fees paid are applied to the purchase (minimum buyout is 5% of list price).

The 1-Month, 20%, 50% Credit Plan

This plan enables you to rent equipment for as little as one month! First month's rental is 20% of list price. The rental declines each month until it reaches 2% of list price in month 22 and remains there for the length of the rental. If you choose to buy, 50% of the rental fees paid are applied to the purchase (minimum buyout is 5% of list price).
